Sub: Upgradation in respect of above said school.

Sir/Madam,

With reference to your application dated 28/06/2011 and subsequent inspection of the school, I am directed to convey sanction for provisional affiliation to the above said school for **Senior School Certificate Examination** for a period of **three years w.e.f. 01.04.2012 to 31.03.2015** in the following subjects:-

- (a) Languages: - ENGLISH CORE, HINDI CORE
(b) Elective Subjects: - HISTORY, POLITICAL SCIENCE, ECONOMICS, SOCIOLOGY, PHYSICAL EDUCATION, MATHEMATICS, PHYSICS, CHEMISTRY, BIOLOGY, BUSINESS STUDIES, ACCOUNTANCY, COMPUTER SCIENCE

The sanction is subject to the fulfillment of the following conditions in addition to the general conditions intimated at the time of grant of provisional affiliation for secondary classes:

1. "The school will follow syllabi and courses as per scheme of studies prescribed by the Board for Senior School Certificate Examination and changes made therein from time to time."
2. The school will implement Continuous and Comprehensive Evaluation (CCE) as per the schemes of the Board upto Classes X.
3. As per the newly implemented CCE scheme vide Circular No. 39/20-09-2009 dated 20.09.2009, the students of class X will appear in the Summative Assessment-II (SA-II) conducted at the school level only. However, those students of class X, who opt to move out of CBSE system in Class XI to any other Board, will exercise the option to appear in the SA-II conducted at the Board level. Both the students will get the same certificate issued by the Board at the end of class-X.
4. The school will follow the RTE Act, 2009 and instructions issued thereon by the CBSE/Respective State Govt./UT.
5. The school will provide additional suitable facilities for classes XI and XII, as per requirements laid down in the rules.
6. It will increase the number of books in the Library and equipments in the Laboratories/Workshops with adequate games facilities etc. in consonance with the requirements of the Board for Classes XI & XII.
7. It will appoint only qualified staff to teach Classes XI & XII as per requirements laid down by the Board.
8. It will provide facilities for adequate co-curricular and extra-curricular activities for the wholesome development of the students.
9. It will abide itself by the Affiliation Bye Laws of the Board and other rules and regulations prescribed by the Board from time to time.
10. The school will enroll students proportionate to the facilities available in the school as prescribed in the Affiliation Bye-Laws of the Board which shall not in general exceed the optimum number as under from Pre-Primary to Class XII :-

(d) School running on bigger campus of more than 02 acres, the number of students shall be restricted as per the actual facilities in the school which shall be proportionate to the optimum number mentioned at (a), (b) and (c) above.			

(e) Schools running on less than 01 acre campus shall restrict number of students as follows:-

11. School will provide physical facilities as per norms of the Board. The facilities reported at the time of last inspection are as given under:-

12. The school will strictly adhere with all rules regarding safety of students including Fire fighting, Drinking water, Sanitation, Transportation, etc.

13. The school will apply for further Extension of Provisional Affiliation on the prescribed form together with the prescribed fee of **Rs. 25,000/-** and other essential documents in the preceding year before the expiry of the date.


14. The school will open CBSE pattern classes XI **w.e.f. 1.4.2012**. Accordingly, 1st Batch of class XII of the school will be appearing at the CBSE Examination to be held in **2014**.

15. Other conditions are as per **Annexure 'A'** enclosed.

16. **Special conditions to be complied within three months:-**

- The school is required to appoint PGTs in the concerned subjects.
- Some of the teachers of the school are untrained and appointed on adhoc basis, whereas the school is required to appoint qualified staff and pay salary and allowances to them at par with the salary of corresponding categories of teachers working in the State Govt. Schools.
- The school is required to ensure that pay-scales, DA and other admissible allowances are being paid at par with the corresponding categories of employees working in the State Govt. Schools as per Affiliation Bye-laws of the Board and disburse the salary through Bank & also submit photocopy of acquittance roll after complying with the above condition.
- The school is required to procure more magazines, journals and books relevant to the academic level of students in the library.
- The School Managing Committee is required to be reconstituted having each of 02 parents representative, teacher representatives and 02 Principals of affiliated schools preferably of Kendriya Vidyalaya /Jawahar Navodaya Vidyalaya.
- The school is required to submit the balance sheet for the last three years which is in the name of school itself duly audited by the Authorized Chartered Accountant.
- The document(s) in respect of 8680 sq. mtr. land area submitted by the school is in the name(s) of individuals i.e. in favour of Shri K S Malla whereas as per Affiliation Bye-Laws land should be in the name of School/Society running the school. Therefore, Sale deed or lease deed for 30 years in respect of 8680 sq. mtr. be submitted in the name of Society/ school alongwith certificate of land in the format given at Appendix-VI of Affiliation Bye-Laws. The Affiliation Bye-Laws and land certificate format are available at CBSE website www.cbseaff.nic.in.
